4. Submitter(s) acknowledges that no fiduciary or confidential relationship now exists between PRE and Submitter(s), and Submitter(s) further acknowledges that no such relationships are established between PRE and Submitter(s) by reason of this Agreement or by reason of Submitter's submission to PRE of the Material.
5. Submitter(s) acknowledges that because of PRE's presence in the entertainment industry, it has or may have had access to and/or may independently create or may have created materials and ideas which may be similar or identical to the Material or idea, theme, format, plot or other elements of the Material and Submitter(s) agrees that they will not be entitled to any compensation if PRE uses any such similar or identical material which may have been independently created by PRE or may have come from other independent sources.
6. Submitter(s) agrees to indemnify and hold harmless PRE from and against any and all claims, expenses, losses or liabilities (including, without limitation, reasonable attorney's fees) that may be asserted against or incurred by PRE at any time in connection with the Material including, without limitation, those arising from any breach or alleged breach of the representations and warranties made by Submitter(s) within.
7. Submitter(s) understands that the review, recommendations, advice and suggestions made by PRE of the Material submitted will be made in good faith, based on

the experience of PRE but, in no way, will guarantee the Material will be considered, optioned, purchased or other, by any person or entity.

8. Any dispute between the parties shall be submitted to arbitration in Los Angeles, California according to the then current rules of the American Arbitration Association. The arbitrator selected shall be knowledgeable in and have experience in the motion picture and television industries. By submitting to arbitration, the parties also hereby waive any and all rights and benefits under the laws of the State of California (or elsewhere) to litigate any such dispute in court, it being the intention of the parties to arbitrate any disputes. Such award will provide for PRE and Submitter(s), each respectively, to bear their own costs of arbitration and attorney's fees and the award will be final and binding on each party and their successors and representatives.

9 Submitter(s) states that he/she has read and understands this Agreement and acknowledges that no oral representations of any kind have been made to Submitter(s) and that this Agreement constitutes the entire understanding between the parties and Submitter's signature(s) below shall constitute Submitter's acceptance and agreement with the terms and conditions set forth herein. This Agreement may be amended only by written instrument signed by all parties.

This Agreement shall be governed by the laws of the State of California and any provision of this Agreement which is void or unenforceable shall be deemed omitted, and this Agreement with such provision or part thereof omitted shall remain in full force and effect. This Agreement shall at all times be construed so as to carry out the purposes stated herein.
